Absentee bids will be accepted by Holzman Auctioneers at their SOLE DISCRETION.

Should absentee bids be accepted, a \$500 non-refundable deposit by credit card will be required at the time of submission (deposit only refunded if bids are not successful).

Vehicles purchased by absentee bid will be charged a 13% Buyer's Premium regardless of form of payment. Payment must be made by Noon ET on Monday November 14th, and buyer must agree to strict removal terms.

If total invoice is over \$10,000, balance due must be paid via bank wire (same deadline applies).

Absentee bids must be pre-approved and submitted on the Absentee Bid Application form via Fax or in person by Friday, November 11th at 5:00PM ET.

Not responsible for lost, late or illegible submissions. Absentee bids will be placed "live" by auction staff to the best of their ability as a courtesy- in no event shall Seller or Holzman Auctioneers be responsible for missed, lost or incorrectly placed bids.

Absentee bidder agrees to honor all bids placed up to the agreed upon "max" submitted on the absentee bid application.

Successful absentee bidders will be notified by phone by 5pm ET on the day of the auction.

Bids which are not honored will be charged a dishonored bid fee of \$250 per vehicle, with a minimum of \$500. If this fee exceeds the \$500 deposit, absentee bidder authorizes auctioneer to charge their credit card for any additional dishonored bid fee.

Absentee bidder agrees to abide by all other terms as listed on the separate bidder registration form.
